

2026 Dorset Australia Day Awards Nomination Form

This form is used to make a nomination for Dorset Councils Australia Day Awards. These awards are presented annually and recognise outstanding individuals and organisations that make a real contribution and difference to our community.

Prior to submitting this form, please make sure you have read and understood the below information.

Australia Day Awards will be awarded in the following categories:

- Citizen of the Year must be over 30 years of age as at 26 January 2026.
- Young Citizen must be 30 years of age or younger as at 26 January 2026.
- Community Event of the Year must be a group or person that has staged an outstanding community event or activity in Dorset during 2025 (a new event or one that has been over several years).

Citizen and Young Citizen awards are for:

- An outstanding contribution or representation of the Dorset community (e.g. social, volunteering, environmental, business, sport, arts or cultural).
- A commitment to the community, organisation, or business.
- Positive and inspiring personal attributes showing qualities such as versatility, flexibility, and perseverance in their service to the community, organisation, or business.
- Personal effort and initiative that has made a significant difference to the quality of the community, organisation, or business.

<u>Community Event of the Year Award is for:</u> An outstanding event held in the Dorset municipality within 2025. If nominating more than one event, please complete a separate nomination form.

- Nomination form is to be submitted to Dorset Council no later than 5pm on Wednesday the 17th of December 2025.
- All unsuccessful nominations for the awards are considered for the receipt of a Certificate of Appreciation in the year in which they are nominated.
- Previous recipients of these awards are not eligible to be nominated for the same award again.
- Nominees who have previously received a Certificate of Appreciation are eligible to be nominated in subsequent years.
- Nominees for individual awards must be an Australian Citizen and be a resident of Dorset at the time of the nomination.
- Anyone can submit a nomination except for self-nominations. Self-nominations will not be accepted.
